

FES PERSONAL DEVELOPER LICENSE AGREEMENT

Version 1.0 — © PORTALZ PTY LTD, Australia

IMPORTANT:

This Personal Developer License Agreement (“Agreement”) is a legal contract between you (“Licensee”) and **PORTALZ PTY LTD**, Australia (“Licensor”), governing use of the FES Framework Personal Developer Edition (“Software”).

By installing, copying, or using the Software, you accept and agree to all terms.

If you do not agree, do not install or use the Software.

1. Definitions

1.1 “Software”

Means the FES Framework Personal Developer Edition, including binaries, documentation, tools, and related materials.

1.2 “Developer” or “Licensee”

Means a single human individual who purchases and uses this license.

1.3 “Commercial Use”

Means use of the Software in Licensee’s own products or services, where the Licensee is the sole developer.

1.4 “Redistribution”

Means bundling or distributing the compiled FES DLL as part of a product.

1.5 “Personal Use Scope”

Means commercial or non-commercial use where:

- Licensee is the only developer,
- the Software is used in Licensee’s own personal projects or products,
- there is no redistribution of the DLL except through compiled binaries.

2. Grant of License

2.1 Personal Developer License.

Licensor grants Licensee a non-exclusive, non-transferable license to use the Software **as a single human developer**, for both commercial and non-commercial projects **developed solely by Licensee**.

2.2 One-time fee.

License is purchased once and valid indefinitely for the FES major version available at time of purchase (e.g., all 2.x releases).

2.3 Machine Activations.

Licensee may install and activate the Software on up to **three (3)** personal computers owned or controlled by Licensee.

2.4 DLL Redistribution in Compiled Products.

Licensee may redistribute the compiled FES DLL **only as part of compiled executables** created solely by Licensee.

2.5 License Redistribution in Compiled Products.

Licensee must include a copy of their encrypted FES License file (.feslic) in the same folder where the FES_V2.dll is installed to enable the software.

2.6 No Team Use.

This license does **not** permit use by multiple developers, contractors, subcontractors, companies or defence agencies/contractors.

3. Restrictions

Licensee **must not**:

- sublicense, rent, lease, or share the Software
- allow other developers to use the Software
- redistribute the DLL except inside Licensee's own compiled applications
- reverse engineer, decompile, disassemble, or modify the Software
- use in enterprise, corporate, or government/defence projects
- distribute more than 1,000 units of any product using the Software (Licensee can purchase Corporate License.)
- use the Software in any safety-critical or security-critical environment

Violation of any restriction terminates this Agreement immediately.

4. Commercial Deployment Rules

4.1 Solo Developer Requirement.

Licensee must be the **only** developer involved in any product using the Software.

4.2 Limited Distribution.

Licensee may distribute compiled products incorporating the FES DLL up to **1,000 units** in total.

4.3 Corporate Upgrade Path.

If Licensee exceeds these limits or becomes part of a team:

- A **Corporate License** must be obtained.

5. Intellectual Property

The Software is licensed, not sold.

All rights remain the exclusive property of PORTALZ PTY LTD.

Nothing in this Agreement grants ownership of:

- algorithms
- source code
- cryptographic methods
- branding
- trademarks
- documentation

6. No Warranty

THE SOFTWARE IS PROVIDED “AS IS,” WITHOUT WARRANTY OF ANY KIND.

PORTALZ PTY LTD makes no assurances of:

- fitness for a particular purpose
- correctness
- performance
- non-infringement

Licensee assumes all risk associated with use.

7. Limitation of Liability

To the fullest extent permitted by Queensland law:

PORTALZ PTY LTD is not liable for any:

- direct
- indirect
- incidental
- consequential
- special
- exemplary
- punitive

damages, including lost profits, data loss, business interruption, or security compromises.

8. Compliance and Audit Rights

8.1 Self-Compliance.

Licensee agrees to keep accurate records of:

- machines activated,
- units distributed,
- products using the Software.

8.2 Right to Request Verification.

Licensor may request written confirmation of compliance.

No invasive auditing is performed.

8.3 Upgrade Requirement.

If usage exceeds Personal Developer limits, Licensee agrees to upgrade to a Corporate License.

9. Termination

This Agreement terminates automatically if Licensee:

- shares the Software
- uses it in a team, company, or government context
- exceeds allowed distribution limits
- reverse engineers or modifies the Software
- violates any provisions herein

Upon termination:

- all use must cease,
 - all copies must be deleted.

10. Governing Law

This Agreement is governed by the laws of **Queensland, Australia**, without regard to conflict-of-law rules.

Licensee consents to the jurisdiction of Queensland courts.

11. Entire Agreement

This Agreement constitutes the entire agreement between Licensee and PORTALZ PTY LTD for the Personal Developer Edition.
