FES TRIAL–NON-COMMERCIAL LICENSE AGREEMENT

IMPORTANT:

This Trial–Non-Commercial License Agreement (“Agreement”) is a legal contract between you (“Licensee”) and **PORTALZ PTY LTD**, Australia (“Licensor”).

By installing, copying, or using the FES Framework Trial Edition (“Software”), you agree to be bound by this Agreement.

If you do not agree, do not install or use the Software.

1. Definitions

1.1 “Software”

Means the FES Framework Trial Edition, including DLLs, executables, documentation, sample code, and all related materials provided by Licensor.

1.2 “Non-Commercial Use”

Means private, educational, academic, research, hobbyist, evaluation, or internal experimentation use.

It expressly excludes any activity intended for commercial advantage, commercial use, resale, deployment, distribution, or incorporation into a product.

1.3 “Commercial Use”

Means use of the Software in or for any paid work, business, company, organization, contractor activity, product development, service provision, or deployment to third parties.

1.4 “License Term”

Means one (1) year from date of installation or activation.

2. Grant of License

2.1 Non-commercial license.

Licensor grants Licensee a limited, non-exclusive, non-transferable, revocable license to install and use the Software strictly for **non-commercial** purposes.

2.2 No cost.

This license is provided at no charge.

2.3 Evaluation rights.

Licensee may use the Software solely for:

- private research or experimentation
- academic research
- internal evaluation
- prototype development
- learning, testing, or proof-of-concept work

2.4 No distribution.

Licensee may not distribute, sublicense, sell, rent, lend, lease, host, embed, bundle, or otherwise provide the Software to any third party.

2.5 No deployment.

Licensee may not include or embed the Software in any product, service, or application distributed to others.

3. Restrictions

Licensee shall NOT:

- use the Software for **any** commercial purpose
- use within any business, government, or defence entity
- reverse engineer, decompile, or attempt to derive source code
- modify or create derivative works of the Software
- attempt to bypass Trial limitations or expiry
- use the Software in production systems
- use the Software to provide encryption services to others
- use the Software in any safety-critical or security-critical environment

Any violation terminates this Agreement immediately.

4. License Term and Expiry

4.1 One-year trial.

This license is valid for **one (1) year** from activation or installation.

4.2 Re-registration permitted.

Licensee may obtain a new Trial license after expiration, provided no commercial use occurs.

4.3 Upgrade option.

Prior to expiry, the licensee has the option to upgrade to a commercial license, in which case the software can remain installed and continue to function with an upgraded License File (.feslic).

4.4 Automatic termination.

Upon expiry, if the license has not been upgraded to a commercial license, all use must cease. The Software must be removed from all systems.

5. Intellectual Property

The Software is licensed, not sold.

All rights, title, and interest remain exclusively with PORTALZ PTY LTD and Wolfgang Flatow.

Nothing in this Agreement transfers ownership of:

- algorithms
 - cryptographic methods
 - documentation
 - trademarks
 - branding
 - intellectual property rights

6. No Warranty

THE SOFTWARE IS PROVIDED “**AS IS**”, WITHOUT WARRANTY OF ANY KIND.

This includes, but is not limited to:

- fitness for a particular purpose
- merchantability
- non-infringement
- correctness or reliability

Licensee assumes all risk.

7. Limitation of Liability

To the maximum extent permitted by law:

- Licensors shall not be liable for any damages, including direct, indirect, incidental, consequential, special, exemplary, or punitive damages.
- Licensors shall not be liable for loss of data, loss of profits, business interruption, or security breaches arising from use of the Software.

This limitation applies even if Licensors have been advised of the possibility of such damages.

8. Compliance and Audit Rights

8.1 Self-compliance.

Licensee agrees to ensure that their use remains strictly non-commercial.

8.2 Audit right.

Licensors may, with reasonable notice, request written confirmation of non-commercial use. No invasive or technical auditing is performed.

9. Termination

This Agreement terminates automatically if Licensee:

- violates any restrictions
- attempts commercial use
- attempts redistribution
- reverse engineers or tampers with the Software
- uses the Software beyond the permitted Term

Upon termination, Licensee must cease use and delete all copies.

10. Governing Law

This Agreement is governed by the laws of **Australia**, specifically the jurisdiction of **Queensland**, without regard to conflict-of-law provisions.

Licensee consents to the courts of Queensland for any disputes.

11. Entire Agreement

This Agreement constitutes the complete agreement regarding the Trial–Non-Commercial use of the Software.
